

WAIVER AND RELEASE

IN CONSIDERATION OF my desire to be an advocate for The Chick Mission, Inc. ("TCM") and participate in the process of publicizing the actions and mission of TCM (hereinafter the "Activity");

I HEREBY, for myself, my heirs, executors, administrators, assigns, or personal representatives (hereinafter collectively "Releasors", "I" or "me", which terms shall also include Releasor's parents or guardian of Releasor if under 18 years of age, knowingly and voluntarily enter into this WAIVER AND RELEASE and hereby waive any and all rights, claims or causes of action of any kind arising out of my participation in the Activity; and

I HEREBY agree and consent to my voice, name, and/or likeness being used, without compensation, in films, tapes and all other media for exploitation in any and all media, whether now known or hereafter devised, for eternity, and I release and discharge TCM, and each of their affiliates, managers, members, agents, representatives, predecessors, successors, employees, volunteers, partners, staff, heirs and assigns (collectively "Releasees") from any liability whatsoever of any nature.

I FURTHER AGREE to indemnify, defend and hold harmless the Releasees against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensations or otherwise brought by me or anyone on my behalf, including attorneys' fees and any related costs.

I agree that this Release shall be governed for all purposes by New York law, without regard to any conflict of law principles. This Release supersedes any and all previous oral or written promises or other agreements. In the event that any provision contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect. If a court should find that any provision of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable that said provision shall be deemed to be written, construed and enforced as so limited.

I, THE UNDERSIGNED, AFFIRM THAT I AM OF AGE 18 YEARS OR OLDER, AND THAT I AM FREELY SIGNING THIS WAIVER AND RELEASE. I EXPRESSLY AGREE TO RELEASE AND DISCHARGE EACH AND ALL OF THE RELEASEES FROM ANY AND ALL CLAIMS OF CAUSES OF ACTION AND I AGREE TO VOLUNTARILY GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING LEGAL ACTION AGAINST ANY OR ALL OF THE RELEASEES FOR TCM'S USE OF MY VOICE, NAME OR LIKENESS.
